Justification

In terms of the R&D evaluation, the University is occupying one of the last rungs, leaving behind mostly universities specialised in arts. In the past years, we got stuck as a whole and the rate of our growth is absolutely minimal (according to the outcome of the RIV database).

It is necessary to take steps to stabilise and develop the creative potential of the University:

- Set up the system of the R&D at the University regardless of the external influences (stabilise the support),
- Support development of the major research topics,
- Intensify obtaining of major creative projects (focused on excellence),
- Support the human resources development in R&D (qualification improvement, human resources internationalisation).
- Support the persons and teams that obtain the major projects and achieve high-quality results,
- Support the contractual research (application and public administration sectors),
- Increase involvement of doctorands and fund their performance from the scholarship funds of the faculties.
- Support the R&D publicity we need to clearly identify ourselves (we are unreadable to enterprises, public sphere, etc.),
- Support the publication outcome which bring significant financial funds in terms of the VO evaluation (Jimp, Jsc) and support the application outcome (P, EP) according to the scored Methodology 17+.

Resources:

- Funds from the University Institutional Plan (human resources stimulation and development),
- Funds for the Specific Secondary Education Research (students grant competition),
- Institutional funds for long-term concept development of VO (creative activity support),
- Scholarship fund (support and involvement of students and doctorands in creative activity),
- External income and income from contractual research (creative activity support, infrastructure development),
- Projects (infrastructure development, human resources support, creative activity promotion).

A. Support of Defined Outcome of Creative Activity

The support is focused on accepted and approved types of outcome and other key areas of the University creative activity which will bring financial funds to various sections of the University budget in the years to come. These are the financial funds which are bound to the specific types of accepted and approved outcome of the creative activity which the University uses to support those employees or students, whose performance contributes to sustainable development of the creative activity at the University.

Basic features of support:

- The resource of the financial support is the University Institutional Plan for the respective year.
- These are non-capital financial funds.
- The maximum amount of the personnel expenses is 15%.
- The support for the outcome mentioned below can be provided only to the University employees or students.
- If the author of the below-mentioned outcome is only the student (Bc., Mgr. or doctorand), the support is paid from the scholarship fund of the faculty at which the student(s) studies.
- The applications are to be filed electronically at the University Research and Development department, using the defined form (included in the document).
- The support can be applied for only by the author (owner) of the given outcome at any time after it is approved and published in the respective creative outcome database¹. In exceptional cases (illness), the support can be applied for by the dean or rector for the author of the outcome.
- There is not any legal entitlement to the financial support, the support is provided only until the allocated financial funds are exhausted.
- The support can be requested for the outcome applied from 1 January 2017.
- The decision on the support allocation and its amount is the competence of the vice-rector for science.

¹ The respective database means the official creative outcome database administered by the respective authority that is the provider of the financial funds for science and research. This is not the internal database of the University.

A. Creative Outcome Eligible to the Support

A1. Support of World-Leading and Excellent Creative Outcome

This is a one-time support bound to the creative outcome that is identified as "world-leading" or "excellent" according to the applicable research organisation evaluation methodology or as "AKX" according to severity and scope. Further, this is an outcome that is indexed in the internationally accepted citation databases and is ranked in the first decile of the research performance indicator.

A2. Support of Application Outcome of Creative Activity

This is a one-time support bound to non-publication outcome of the creative activity in connection with meeting of certain criterion.

A3. Support of Journal Publication

This is to support performance of the journal offices of the University which are included in the Web of Science (WoS) or Scopus (SC) databases.

The support amount is determined as a sum of 2 parts, a fixed one (inclusion in the respective database) and the performance-based one aimed on improving the quality and expanding publications in the journal (IF or SRJ index of the journal and number of articles published by the University employees or students in the given year.

The maximum amount of support per journal for the subject year is CZK 100,000.

The support amount (both fixed and performance-based parts) is determined retroactively for the past year as of 31 May of the following year. If the journal is included in both WoS and SC, only 1 database is subject to the support.

A4. Support of Successful International Creative Projects

This is a one-time support bound to acceptance and funding of solution of the respective international scientific research project² by the provider of the financial funds in the given category.

This is a one-time support bound to acceptance and funding of solution of the respective national scientific research project by the provider of the financial funds in the given category.

B. Support of Other Areas of Creative Activity

The area of support concentrates on the other areas of creative activity which are important for continuous development of the University in terms of the creative activity.

B1. Support of Habilitation and Professor Appointment Procedures

This is a one-time support bound to successful completion of the habilitation procedure or professor appointment procedure. Only full-time University employees are eligible for the support.

B2. Contractual Research Support

This is a one-time support bound to successful establishment and development of cooperation with the application or public administration sphere. Under this cooperation, the University personnel or students get engaged in solution of research topics of a particular enterprise or institute with concurrent financial benefit to the University.

The outcome of mutual cooperation in area of creative activity shall meet all of the conditions of a contractual research study according to the applicable methodology, summarised in a "summary research report" and the contractual research is reported and approved in the respective database of evaluated outcome of creative activity of a research organisation.

The support of this cooperation can be applied for at any time after the contractual research outcome is accepted by the respective provider of the financial funds for research and development.
